To ensure patients who receive care from Trava Health Clinic are comfortable in entrusting their health information to the practice This Privacy Policy sets out our commitment to protecting the privacy of personal information provided to us, or otherwise collected by us, offline or online, including through our website www.travahealth.com.au

Patient's Consent

Trava Health Clinic will only interpret and apply a patient's consent for the primary purpose for which it was provided. The practice staff must seek additional consent from the patient if the personal information collected may be used for any other purpose.

Personal information

The types of personal information we may collect about you include:

- Your name contacts details, including email address, postal address or telephone number;
- your age and/or date of birth;
- your credit card details;
- medical History;
- your preferences and/or opinions;
- Data collection such as your browser session and geo-location data, search queries, browsing behaviour, your access and use of our site, including data cookies;

- third parties to collect and process data, such as [Google Analytics or other relevant businesses]. This may include parties that store data outside of Australia.

How do we treat personal information that is also sensitive?
